St. Boniface Hospital Foundation launched a major fundraising campaign to purchase and install the scanner. The campaign was chaired by Abdo (Albert) El Tassi; anchored by a \$1 million gift from Russ and Edna Edwards; and supported by many generous donors in the community.

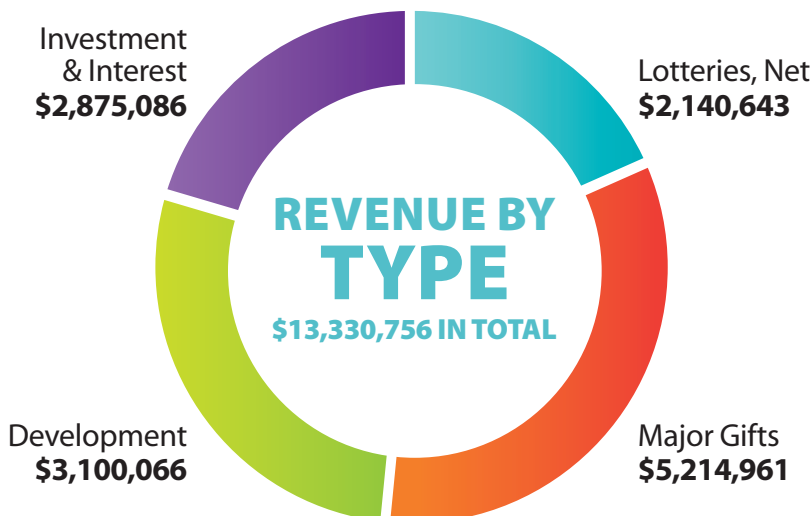

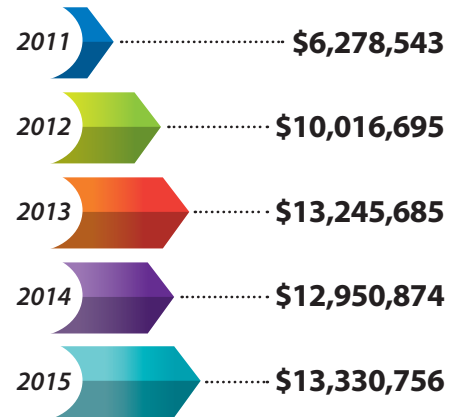

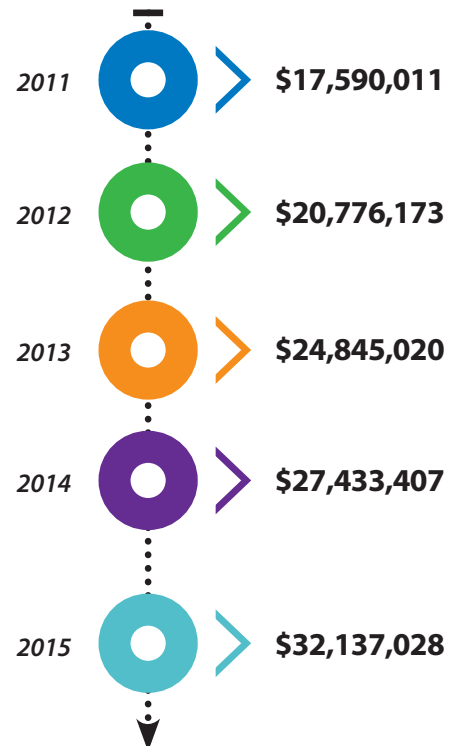

And we consider each and every donor to be a partner, too. You *care* about what we do. You *understand* what we do. And you *invest* in our success.


